
Jurisdiction & Organization

The Ohio Revised Code, Title 19, Chapter 1901 establishes and sets forth the authority and jurisdiction of the Canton Municipal Court.

The Canton Municipal Court is a limited jurisdiction court of record which has jurisdiction over any violation of city ordinances; any State of Ohio statutory misdemeanor or traffic offense; and jurisdiction to preside over felony preliminary hearings for offenses committed within the geographic boundaries of the Court. Jurisdiction also includes civil matters where the dispute is \$15,000 or less and for small claims when the claim is \$6,000 or less.

The four Judges of the Court are elected to staggered six year terms on a non-partisan ballot. A person seeking election or appointment to the Canton Municipal bench must be an attorney with at least six years experience in the practice of law and reside within the Court's jurisdiction. The Governor of the State of Ohio makes appointments to fill vacancies on the Municipal Court bench that occur between elections.

The Canton Municipal Court serves a district with the population of nearly 200,000 citizens of Central Stark County and hears more than 20,000 cases annually.



Judge Mary A. Falvey



Judge Mary A. Falvey, has served as a Canton Municipal Court Judge since January 1991. Prior to that, she was a law partner with the firm Schulman, Mestel, Falvey and Burick Co. L.P.A. in Canton, Ohio, a firm whose primary focus was civil litigation.

Judge Falvey graduated from Fairmont West High School in Kettering, Ohio. She earned her B.S.S.W. *cum laude* from The Ohio State University in 1973. She received her Juris Doctorate from the University of Akron in 1979.

Judge Falvey has been active in many civic and charitable organizations. She has served as a member of Big Brothers Big Sisters Advisory Board from 1988 through 2000, including serving as President of the Board in 1992. She has served as a member of the Junior League of Canton, Community Advisory Board. Judge Falvey has been the district coordinator for the Ohio Mock Trial program since 1994. Judge Falvey also presides over the Polaris Program, the Court's specialized Mental Health Court docket.

In 2017 Judge Falvey was presented the HOPE Award by the Stark Mental Health & Addiction Recovery Board in recognition of her on-going commitment presiding over the Polaris Mental Health Court Docket.

Judge Falvey has served as a member of the University of Akron Law Alumni Association. She has also served as a member of the Stark County Community Corrections Planning Board and the Canton Municipal Court Domestic Violence Council. She is also a member of The Ohio State Bar Association, the Stark County Bar Association and the Municipal Court Judges Association.



Judge Ríchard J. Kubílus

Judge Richard J. Kubilus has served as a Canton Municipal Court Judge since January 1993. Prior to that time, he served as a law partner with Lesh, Casner & Miller Co. in private practice. In his private practice, he had fifteen years of trial experience involving commercial and civil litigation, real estate, business organization and family planning matters. He also served as a Plain Township Trustee from September 1990 through December 1992.

After graduating from Walsh Jesuit High School in Stow, Ohio, Judge Kubilus earned his BA *cum laude* from the University of Akron in 1974. He received his Juris Doctorate from the University of Dayton School of Law in 1978. He is married to his wife Linda, with one son Eric.

Judge Kubilus is active in many community and charitable organizations. He has served as a Board Member of the Community Harvest, the North Canton Rotary Club and the Stark County Bar Association. He is a former group leader of the Boy Scouts Law Explorer Post, and has served as member of the Stark County Children Services Committee, the Pro Football Hall of Fame Enshrinement Committee, the United Way Allocation Committee, St. Paul's Church and the Unique Club. Judge Kubilus is a graduate of Leadership Stark County and a member of the Ohio State Bar Association and the Municipal Court Judges Association.



Presiding & Administrative Judge Curt Werren

Judge Curt Werren grew up in Canton and graduated from McKinley High School. He came back to Canton after completing law school at The Ohio State University and practiced law for twenty years with Day Ketterer Ltd. Judge Werren was also Executive Director of the Stark County Regional Chapter of the American Red Cross. Prior to joining the Canton Municipal Court, Judge Werren served as Judge of the Stark County Court of Common Pleas. Judge Werren has been active in the community. He is on the Board of the McKinley Presidential Library and Museum and the SAM Center. Among notable prior activities, Judge Werren served with the Stark County Mental Health and Recovery Services Board and has been President of the Rotary Club of Canton. He also co-chaired the campaign to develop the Community Campus at Goodwill. In addition to his regular docket, Judge Werren presides over the Recovery Court, a drug court certified by the Supreme Court of Ohio. Judge Werren was awarded the 2017 HOPE Award for his efforts with the Court's specialized dockets. Judge Werren is a life-long Stark County resident who is married to Stephanie, Director of Leadership Stark County. They raised triplet children who are now grown.



Judge Kristen D. Guardado



Judge Kristen Donohue Guardado was born and raised in Stark County. A graduate of McKinley Senior High School, Judge Guardado earned her Bachelor Degree in Finance followed by her Juris Doctorate from the University of Akron, School of Law.

Judge Guardado began her legal career as a Legal Intern at the City of Canton Law Department in 1994 and eventually served as Assistant Prosecutor; Domestic Violence Prosecutor and Senior Trial Counsel. Judge Guardado also had a private practice specializing in family law where she handled domestic relations cases, criminal juvenile matters, dependent/neglect/abuse cases and served as Guardian ad litem in numerous cases. Judge Guardado previously held elected office on the Plain Local Board of Education from 2001 through 2020 where she served as President, Vice President and Legislative Liaison.

In 1997 Judge Guardado was presented the Award for Special Achievement in Domestic Violence Advocacy by the Ohio Attorney General Office for her years of professional and volunteer efforts advocating for additional services and funding for victims and families of domestic violence. She was also recognized by the Stark Regional Chamber of Commerce in 2011 as a "Twenty under 40" recipient.

Judge Guardado has been a member of the Stark County Bar Association since 1996 and served on numerous Bar committees. She is also a member of the Ohio Bar Association and the American Bar Association.

Judge Guardado resides in Canton with her husband Vince and they have two adult sons.

Phíl G. Giavasis Clerk of Court



Phil G. Giavasis was appointed Clerk of the Canton Municipal Court in July of 2007, and was elected to the full term beginning in January 2008. He previously served 15 years as Clerk of the Stark County Common Pleas Court.

Phil is a 1980 graduate of McKinley Senior High School. He also graduated with a BA in Criminal Justice from Edinboro University of Pennsylvania, and graduated in 2004 from the Institute of Court Management as a Certified Court Manager.

Phil Giavasis led the initiative that resulted in the computer integration of the entire criminal justice system in Stark County. He organized and currently chairs the Stark County Criminal Justice Information System (CJIS) Steering Committee, a subcommittee of the Stark County Community Corrections Planning Board; the body that oversees the integrated system.

The Stark County <u>Criminal Justice Information System</u> (CJIS) was the first county-wide integrated system in Ohio and was developed with a series of grant funds from the Office of Criminal Justice Services totaling over one million dollars. The CJIS system combines the criminal justice information of the Canton, Massillon, and Alliance Municipal Courts with the Sheriff and Stark County Court of Common Pleas. The countywide central database is currently web accessible at www.starkcjis.org

Court Administrator

The Judges of the Court appoint a Court Administrator to manage and oversee the operations of the Court. The Court Administrator serves as the chief non-judicial officer of the Court and is responsible for the development and implementation of all court policies, procedures and programs, as well as the general supervision of the Court Magistrates, Staff Attorney, Probation Department, Pretrial Services Office, Bailiff's Office, Community Service Department, Jury Coordinator, Assignment Coordinator and related clerical, support and contract staff.

Other executive functions of the Court Administrator include: preparation and management of the annual court budget, personnel and human resource administration, legislative research and analysis, grant management, contractual services, coordination of technology, procurement of equipment and supplies, facility management, review and analysis of statistical reports and departmental performance. The Court Administrator also serves as a liaison with local, county and state government, courts and the public.



Court Administrator Michael Kochera

Michael Kochera has more than 35 years of experience in the criminal justice system and judiciary. Michael is a past-President of the Ohio Association for Court Administration; a former Executive Board Member of the Ohio Justice Alliance for Community Corrections; a member of the National Association for Court Management, and an Executive Board Member of the Stark County Corrections Planning Board. Michael served as an Ad Hoc Committee member on the Ohio Criminal Sentencing Commission's Subcommittee on Bail Reform from 2016-2019. Michael has served as Adjunct Faculty for the Judicial College of the Supreme Court of Ohio and is a graduate of the Court Executive Program, Class of 2013 through the Supreme Court of Ohio and the National Center for State Courts. In 2010, Michael was awarded the inaugural *Chief Justice Thomas J. Moyer Memorial Scholarship* presented by the Ohio Association for Court Administration and in 2008, Michael was awarded the *Quest Criminal Justice Services Award* for his outstanding contributions to the Stark County criminal justice system. Michael is married to Rachel Kochera with a daughter Mallory and son Leo.

Court Magistrates

The Canton Municipal Court Magistrates undertake specific judicial duties as prescribed by the Supreme Court of Ohio. Magistrates Jeremy J. Foltz, Derek C. McClowry, and Christy Pierson preside over minor misdemeanor criminal and traffic cases; Forcible Entry & Detainer (eviction) cases; Damage Hearings; Contract cases; Bank/Wage Attachment Hearings and Small Claims cases.

All of these proceedings are docketed by a written report of the Magistrate stating their findings of fact and conclusions of law. These reports are then reviewed by a Judge of the Court who finalizes a Judgment Entry with the Judge's approval and confirmation.

Magistrate Jeremy J. Foltz has served the Canton Municipal Court since 2006. Magistrate Foltz graduated from Canton GlenOak High School and went on to earn a Bachelor of Arts degree from Bowling Green State University in 1996. He received his Juris Doctorate from the University of Akron in 1999. Magistrate Foltz has been active in many civic and charitable organizations. He currently sits on the Board of Wishes Can Happen and is currently the Vice President of the Plain Local Schools Foundation. In 2016 Magistrate Foltz was presented with the Pro Bono Award presented by Community Legal Aid of Greater Stark County for his significant and generous pro bono work in the community. Magistrate Foltz is a member of the Ohio State Bar Association, the Stark County Bar Association and the Ohio Magistrate Association. A lifelong member of Trinity United Christian Church, Magistrate Foltz resides in Plain Township with his wife and two children.

The Court's Staff Attorney not only serves as legal advisor to the Judges, Magistrates, and Court Administrator, but also serves as Magistrate for the Court. The Staff Attorney conducts legal research, prepares legal briefs and coordinates legislative research and analysis. The Staff Attorney also assists in policy development and review and serves as a liaison between the Court and Supreme Court of Ohio.

Magistrate Christy Pierson has served the Canton Municipal Court since March 2020. Prior to her appointment with the Court, Christy served as an Assistant County Prosecutor with the Stark County Prosecutors Office from 2017 to 2020 as well as an Assistant City Prosecutor with the Canton Law Department from 2015-2017.

Christy graduated from Hoover High School and went on to earn a Bachelor degree from The Ohio State
University in 1995. She received her Juris Doctorate from the University of Akron in 2014. Magistrate Pierson is an alumna of the Canton Ballet and currently sits on the Board of Director's Past President. Magistrate Pierson is a member of the Ohio Bar Association, the Stark County Bar Association and the Ohio Magistrates Association. She resides in Plain Township with her husband and has two adult children.



Probation Department

Although the primary role of the Canton Municipal Court Probation Department continues to be the probation supervision of offenders and the enforcement of court orders, there are a myriad of other vital functions the Probation Department performs. Probation Officers conduct field contacts with offenders at their homes, places of employment and at counseling and other appointments, in addition to seeing offenders as frequently as weekly in the office. Probation Officers also perform random drug and alcohol testing on offenders, conduct pre-sentence and expungement investigations, supervise curfew compliance and oversee the collection and payment of restitution to crime victims.

However, the role of the Probation Department is not simply enforcement. Probation Officers also serve as advocates for offenders under supervision. Probation Officers assist offenders in accessing services in the community such as counseling services, employment and vocational services, educational services, adequate housing and medical treatment services.

Providing offenders the tools necessary to become productive members of the community is the cornerstone of successful probation supervision and intervention.

All defendants sentenced to Probation Supervision are assessed via the Ohio Risk Assessment System (ORAS) in order to determine the level and frequency of supervision and services they will receive. Based upon the result of the risk/needs assessment, defendants are classified as Low, Moderate, High or Intensive Supervision. The initial level of supervision determines how frequently a defendant is required to report to their Probation Officer, how frequently they will be drug tested and assists in determining other goals for the defendant. As a defendant demonstrates compliance with the conditions of probation and orders of the Court, their level of supervision is revised accordingly.

The Probation Department, Court and community as a whole have a vested interest in assisting offenders in the rehabilitation process in order to prevent them from continuing to be involved in the criminal justice system, and consequently a further expense to the tax-paying public.



The Canton Municipal Probation Department has been awarded the prestigious Clifford Skeen Award presented by the Ohio Department of Rehabilitation & Corrections (ODR&C) an unprecedented three times.

The Clifford Skeen Award is presented annually by ODR&C to recognize the most effective community corrections programs in the State of Ohio. The Canton Municipal Probation Department was awarded the Skeen Award in 2011, 2017 and 2019.

Probation Case Activity



During 2024 the Probation Department closed 244 cases with 56 revocations and 188 successful completions for an effective completion rate of 77%

The Probation Department collected \$41,774 in restitution during 2024 that was directly refunded to victims of crime.

Polaris Project



"A revolving door problem has developed in this country. Jails and prisons have become the de facto mental health system of our day. We must reverse this trend."


Justice Evelyn Lundberg Stratton, Supreme Court of Ohio, Retired

The Polaris Project is a certified Specialized Docket through the Supreme Court of Ohio that provides a comprehensive, coordinated approach to the misdemeanor cases of defendants with severe mental illness and/or co-occurring disorders in order to decrease criminal recidivism, improve public safety and improve the defendant's quality of life by stabilizing the defendant in the least restrictive environment. The Polaris Project is a voluntary program that emphasizes the early identification and intervention of a person whose symptoms of mental illness, history of treatment non-compliance, and/or refusal to accept treatment, results in a recurring pattern of misdemeanor offenses.

Judge Mary A. Falvey has presided over the Polaris Project docket since 2009. The Polaris Project is a coordinated treatment and supervision program intended to promote effective treatment as an alternative to incarceration. Through frequent judicial interaction and intervention, the Program assists defendants in recognizing, taking control, managing and being accountable for their mental illness.

The Polaris Project is a cooperative effort between the Stark Mental Health & Addiction Recovery Board, Stark County TASC and the Canton Municipal Court.

During 2024, thirty-one new participants entered the Polaris Project and 15 participants successfully completed the program.



- Bipolar Spectrum Disorders
- Depression or Anxiety Spectrum Disorders
- Schizophrenia or Related Disorder

- 15 individuals successfully completed the Polaris Program in 2024. Had they not been admitted to the Program and served their jail sentence, they could have served in excess of 2,720 days in jail.
- 60% of those successfully completing the Program have maintained their recovery and not re-entered the criminal justice system one year post completion.
- Of those admitted to the Polaris Program, each averaged 3 prior arrests.
- 60% of participants had a history of substance abuse and/or dependency

Recovery Court

The Canton Municipal Court, Recovery Court is a voluntary program intended to promote appropriate and effective treatment of substance use disorder, including the use of medically assisted recovery (MAR) when clinically indicated, as an alternative to incarceration for a person whose history of treatment non-compliance, and/or refusal to accept treatment, results in a recurring pattern of criminal offenses. The Program requires court and treatment provider involvement in treatment planning and compliance, which should result in more effective utilization of other court and system resources.

The Program will provide a non-adversarial, comprehensive, coordinated approach to the criminal cases of selected defendants with a history of substance use disorder in order to decrease criminal recidivism, improve public safety and improve the defendant's quality of life by stabilizing the defendant in the least restrictive environment. The Recovery Court is a voluntary hybrid program whereas participants can enter as a condition of Intervention in lieu of Conviction, pursuant to Ohio Revised Code, Section 2951.041 or via referral post-conviction as a condition of probation. The duration of the Recovery Court program varies based upon a participant's program performance and compliance with the conditions of participation, but generally twelve months.

The Honorable Curt Werren presides over the Canton Municipal Recovery Court. The Recovery Court commenced operations in March of 2017 and achieved certification from the Supreme Court of Ohio in August 2017. In addition to a full continuum of treatment services, the Recovery Court provides case management and peer support to all those engaged in the Program.

During 2024, forty defendants were accepted into the Recovery Court Docket. Twenty-four defendants graduated from the program during 2024, twelve felony diversion cases and 12 misdemeanor cases. To date, 45% of the Recovery Court participants are/or have been engaged in Medically Assisted Recovery (MAT).

The Recovery Court is a collaborative initiative between the Stark Mental Health & Addiction Recovery Board, CommQuest and the Canton Municipal Court.



Veterans Treatment Court

In keeping with her campaign commitment to provide a Specialized Docket to serve those who served, in 2024 Judge Kristen D. Guardado implemented the Canton Municipal Court, Veterans Treatment Docket. This Specialized Docket was developed to address and provide assistance to the unique challenges of our military veterans that are involved in the local criminal justice system.

With the recognition that many of our veterans return to civilian life with serious trauma, both physical and mental, which may lead to their involvement with the criminal justice system, comes a responsibility to ensure that veterans receive the treatment they need. By providing a Veterans Treatment Specialized Docket in the Canton Municipal Court, the program promotes sobriety, recovery and stability through a coordinated response that involves cooperation and collaboration with the Stark County Veterans Service Commission, the Veterans Benefit Administration, Volunteer Veteran Mentors and Veterans family support organizations.

The Canton Municipal Court, Veterans Treatment Court (VTC) is a voluntary program to address the issues of veterans with specific needs or circumstances not adequately handled in the traditional court system. Justice-involved Veterans are able to go through the treatment court process with other veterans who are similarly situated and have common past experiences and needs. The VTC links participants with service providers who either share or understand the unique experience of military service, military life, and the distinctive needs that may arise from that experience.

The Program provides a non-adversarial, comprehensive, coordinated approach to the criminal cases of selected defendants with a history of substance use disorder and/or mental health disorder in order to decrease criminal recidivism, improve public safety and improve the participant's quality of life by stabilizing the participant in the least restrictive environment. The VTC is a voluntary hybrid program whereas participants can enter via the Diversion Program track or via referral post-conviction as a condition of probation. The duration of the VTC program varies based upon a participant's program performance and compliance with the conditions of participation, but generally twelve months.

The Veterans Treatment Court commenced operation in Fall of 2024 and has since been granted full certification as a Certified Specialized Docket by the Supreme Court of Ohio.



Court Security

The Bailiff's Office is composed of three separate divisions; Judicial Bailiff division, Service Bailiff division and Court Security division.

The Judicial Bailiffs serve as personal Bailiff to each of the Court's four Judges.
Responsibilities of the Judicial Bailiffs include maintaining security in the courtroom, the orderly flow of cases on the daily docket, completion of required case documentation, swearing in witnesses, handling and marking exhibits, and the operation of the court recording devices.

In addition to operating the X-ray screening device and magnetometer, the Court Security Bailiffs screen and search all visitors to the Court and City Hall, respond to security situations within the Court, assist in escorting prisoners, and taking offenders into custody. In 2024, the Court Security Bailiffs screened 76,092 visitors to the Court.

Each of the Court Security Bailiffs have completed the Bailiff Training Academy at the Ohio Peace Officer Training Academy in London, Ohio and have been trained and certified in unarmed-self defense tactics, firearms, first-aid, CPR, use and deployment of oleoresin capsicum (OC) spray, as well as emergency procedures and critical incident management.

Court Security Bailiffs are also responsible for conducting the booking process on defendants appearing in Court. This process entails the Security Bailiff fingerprinting defendants on an automated fingerprint identification system and transmitting the prints and other vital arrest information to the Ohio Bureau of Criminal Investigation and Identification at the Ohio Attorney General's Office. During 2024, the Court Security Bailiff's booked 867 defendants.



Bailiffs Office

Court Deputy Bailiffs also provide vital and statutory services for the Court and the local criminal justice system. The Court utilizes three Deputy Service Bailiffs for the service of summons, subpoenas and other court papers to the general public. These official notices are served not only on behalf of the Court, but also for the City of Canton Law Department and Prosecutor's Office. During 2024, the Deputy Bailiffs served 35,101 subpoenas, summons, and other related court notices.

The Deputy Service Bailiffs are also responsible for the oversight and supervision of all evictions within the Court jurisdiction. Upon the conclusion of the court hearings and legal procedures during the eviction process, the Deputy Bailiffs serve as legal stewards to gain entry and take possession of the property on behalf of the property owners. During 2024, the Court heard 1,740 eviction cases and the Deputy Bailiffs executed 990 Evictions set-outs.

The Court's other three Deputy Bailiffs serve in the Court and fulfill a number of essential functions. One Deputy Bailiff serves as the Bailiff for the Court's three Magistrates; one assists the Arraignment Judge; and the remaining Deputy Bailiff processes applications for limited driving privileges and ignition interlock devices for those with suspended operators license. The Deputy Bailiffs also provide back-up coverage for Court Security Bailiffs when necessary.

Community Sanctions Department

The Canton Municipal Court Community
Sanctions Department operates under the
philosophy that offenders performing
volunteer work service within their
community not only serves to repay a
wrong or debt to the community, but
allows the offender to have a personal
investment in the end product of a better
community.

Community Service offers the Judges of the Court a community-based sanction alternative to a jail sentence for non-violent and first time offenders.

The Community Sanctions Department has developed relationships and inter-agency agreements with several dozen charitable and non-profit organizations throughout Stark County, as well as working relationships with various City Departments. The role of the Community Service Department is to screen and place offenders sentenced to community service into these sites to perform volunteer community work service. Offenders are supervised by Court Community Sanctions Supervisors or individual agency personnel or a combination of both while performing community work service.

During 2024, 975 offenders were sentenced to 37,937 hours of supervised Community Work Service and completed 26,668 hours or 71% of the hours sentenced. If not for the Community Work Service Program and had those 975 offenders been sentenced to jail, they would have accounted for a total of 64,120 jail bed days. Based on the number of community service hours completed by offenders in 2024 when translated in terms of labor at minimum wage it represents a total of \$405,926 of labor services provided to these agencies.



Community Sanctions Department

The Community Service Department also operates its own Road Crew. Offenders sentenced to the Road Crew are directly supervised by the Community Sanctions Supervisors weekdays from 8:00 am to 4:00 pm. While assigned to Road Crew, offenders perform litter control and other basic labor services, as well as lawn maintenance and snow removal at various City properties and for the elderly and disabled within the Court's jurisdiction.

Each of the Community Service Road Crew Supervisors operates a 10 passenger van and equipment trailer that serves as their own self-contained, clean-up and maintenance shop. The Road Crew Supervisors work off of a daily schedule of lawn mowing, snow removal and clean-ups for the City of Canton Code Enforcement and Health Department at locations in the community cited for Code Violations. The Road Crew Staff supervises up to 10 offenders each for two 4 hour shifts daily.

The Community Sanctions Officers also serve as a liaison between the Court and community treatment agencies. The Community Sanctions Officers monitor defendants' compliance with court-ordered treatment obligations for mental health, drug/alcohol issues as a part of their sentence. The Community Sanctions Officers maintain contact with the defendant and the community treatment agencies through the completion of the treatment obligation. During 2024 the Community Sanctions Officers monitored 789 defendants involved in court-ordered counseling obligations.

Pretrial Services Office

The mission of the Canton Municipal Pretrial Services Office is to provide the Judges of the Court with a risk-based recommendation for pretrial release or detention for defendants appearing for arraignment; provide risk-based supervision for those released from custody pending trial and implement strategies to maximize court appearance and maximize public safety.

The Municipal Pretrial Services Office partnered with the Laura & John Arnold Foundation for professional training and implementation of the Public Safety Assessment (PSA). The PSA is a nationally recognized, validated, race and gender neutral pretrial risk assessment that utilizes defendant risk factors to accurately predict a defendant's likeliness to appear for court; likeliness to commit a new offense while under pretrial supervision as well as the proclivity of committing a new violent offense while under supervision while awaiting trial. While the PSA is not a crystal ball that provides 100% certainty of these behaviors, it does provide the Judges of the Court another tool in making the decision to release or detain a defendant while awaiting trial.

Upon the determination that a defendant may be released from custody while awaiting trial, the Municipal Pretrial Services Office actively supervises defendants while in the community based upon the level of risk the defendant presents. The Municipal Pretrial Services Office utilizes an array of available technologies in supervising defendants, including automated text and email notifications, electronically-monitored house arrest; 24 hour subcutaneous alcohol monitoring; active global positioning satellite (GPS) monitoring with exclusion zones as well as requiring in person office visits and phone call ins.

Court and jail data for the Municipal Pretrial Services Office operation demonstrates the Municipal Pretrial Office has effectively achieved all of the outcome measures prescribed by the grantfunding authority. The Pretrial Office has reduced the Failure to Appear rate by 57%; reduced the average number of defendants being held prior to trial by 40% and reduced the average number of days defendants were held by 36%.

Jury Service

A significant portion of the cases heard by the Court each year have the potential to be decided by a jury trial.

In preparation for that potential, the Jury Coordinator is charged with securing, scheduling, and coordinating an ample jury pool. The Jury Coordinator obtains a random sample of registered voters that reside within the Court's jurisdiction from the Stark County Board of Elections each quarter in order to adequately schedule for Jury Duty. The Jury Coordinator then prepares a Summons for the prospective juror to be "on-call" for one week

In order to further simplify the process of reporting for jury duty, the Court leveraged existing technology and offers email and text notifications for jury duty.

The Court sincerely appreciates the juror's appearance for this civic obligation and without their commitment and participation in the process, the justice system as we know could not exist.








2024 Filings by Case Type





2024 Criminal Charges by Police Agency


Criminal/Traffic Charges Filed by Police Jurisdiction
